YoungMinds Cookie Policy

Please read this cookie policy carefully as it contains important information on how we use cookies on our website. This policy should be read together with our <u>Privacy Policy</u> which sets out how and why we collect, store, use and share personal information generally. It also sets out your rights in relation to your personal information and details of how to contact us and supervisory authorities (organisations that make sure we're following the right rules and regulations) if you have a complaint.

What are cookies?

Cookies are small text files that are stored on your computer, phone or any device you use to access our website. They are used on most websites.

When you visit the Young Minds website, we use these cookies stored on your device to help us improve the website with things like making our pages easy to find and look through, more informative and user friendly. It helps us improve our services to young people, parents and carers as well as professionals working with young people.

These cookies are downloaded and stored when you visit our website and can be used at a later date. They also help us to recognise you and your device and store some information about your preferences or past actions. This is things like if you've visited our website before and you've come back and what pages you look at.

Types of cookies

Necessary cookies

These cookies are necessary for our website and services to operate (work). They do not access or store any personal data. Our website cannot function without these cookies, so they are always set on.

Performance Cookies

Performance Cookies also known as analytic cookies allow us to measure and report on website activity. This includes things like how many people came to our website, how users look at different pages, how they find different pieces of information and when they are using our website. This helps us to improve the way our website works for you.



Analytics cookies are also used to identify devices looking at our website and third-party sites like Instagram or YouTube to see if there is any abuse happening on these sites. Analytic cookies do not collect information that directly identify you as an individual.

Marketing Cookies

Marketing cookies or any other form of local storage is used to create user profiles to send advertising (ads about other websites that might be helpful to you). They are also used to track a user across several websites for marketing purposes. Some of these cookies include cookies from third party sites who can collect data about the user and combine it with other cookies from websites to display adverts.

Third party cookies

Some of the cookies that are used for analytics or marketing are third party cookies. These cookies are from other websites that help us with the performance of our website and help us understand how you are looking at our site. The third-party sites include but are not limited to:
