Terms and conditions

Challenge events

Thank you for choosing to take part in a challenge event for YoungMinds. Because of supporters we can keep fighting for a world where no young person feels alone with their mental health.

The terms and conditions below ensure that you know where you stand as a fundraiser. Please read them carefully and ensure you are happy to accept them. You are deemed to accept the terms and conditions if you go on to take part in a Challenge Event through YoungMinds.

These Terms & Conditions govern your participation in your chosen event ("the Event").

You, as the participant acknowledge that the Event is organised by a third party ("the Organiser") with whom you have a separate agreement and its Terms and Conditions should be read in conjunction with these set out below.

Places given by YoungMinds will henceforth be known "Charity Place". These differ from "own places" when a supporter has sourced themselves and has then chosen to fundraise for YoungMinds.

Charity place specific Terms and Conditions

- As you have been given a place by YoungMinds in The Event you pledge to raise the
 minimum sponsorship target for YoungMinds for the event in which you are
 participating. The sponsorship target set and amount raised both do not include Gift
 Aid.
- You must be registered with YoungMinds and with the Organiser. You acknowledge that
 failure to respond to communications from YoungMinds' Challenge Team about
 completing the Events registration process or fundraising for YoungMinds may put your
 event place at risk.
- You must pay a non-refundable and non-transferable registration fee (and any applicable VAT) to YoungMinds prior to participation in the Event. A guaranteed place in the chosen event is subject to the payment of the registration fee. - You will not collect donations door-to-door or in a public place without getting a
 collector's licence from my local authority or police. You will follow all charity regulations

- You will not collect donations on private property without the owner's permission. This includes shops and pubs.
- You will not hold a raffle, lottery or prize draw unless it is permitted by Local Authority and Gambling Commission regulation.
